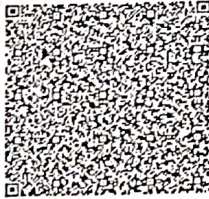

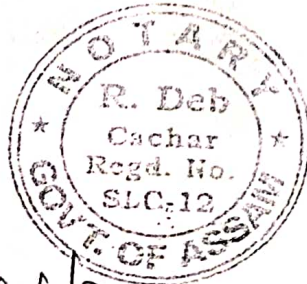

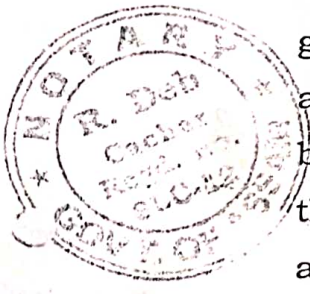

- iii) Both the parties shall sponsor its Faculty/ Support staff




- iv) Both the parties shall undertake all the feasible measures for promoting the activities of the other party.
